Assumption of Risk, Liability Waiver, Release and Indemnity Agreement

In consideration of my membership in Manhattan Beach Badminton Club (“Club”), on behalf of myself, and my respective heirs, executors, guardians, legal representatives, and administrators and assigns, I agree and acknowledge the following, which shall survive any termination of my membership:

1. Club Rules. I agree to abide by the Club’s Bylaws and Principals Governing Use of the Manhattan Beach Badminton Club and Grounds and any other policies or rules of the Club, as such Bylaws, Principals and any other policies or rules, including (a) the payment of dues and assessments, (b) performance of work days, and (c) policies and procedures regarding guests.

2. Assumption of Risk. Participation in Club activities and use of Club facilities is entirely voluntary and for my recreational and social enjoyment. I recognize that use of the Club’s facilities and participation in Club-related activities involves risks and dangers, including but not limited to the risks of personal injury, property loss, drowning, consumption of food or drink, first aid and emergency treatment, and I freely assume all risks including unforeseen risks. The Club is not my insurer. I will maintain such insurance as I deem prudent to protect myself, my family and guests from all risks.

3. Liability Waiver and Release. To the fullest extent permitted by law, I waive all claims, forever release and promise not to sue the Club for any and all harm, loss, personal injury or property loss and any and all actions, causes of action or demands therefore or related to, arising from use of the Club’s facilities or participation in any Club-related activity by me, my family and guests, including as a result of any negligence of the Club.

4. Indemnification, Attorney’s Fees. If I or any third party makes any claim or sues the Club as a result of any act or omission of myself, my family or guests, I promise to hold harmless and indemnify the Club from and against any damage, liability, loss, cost or expense including attorney fees, in connection with such claim or suit. If I sue the Club, the prevailing party will be awarded reasonable attorneys’ fees and costs incurred in such action or proceeding, or in the enforcement of any judgment or award rendered.

5. Interpretation. As used herein, the “Club” shall mean the Manhattan Beach Badminton Club, its owners, members, directors, officers, employees, agents, assigns and representatives of any of them. This Agreement contains all of the understandings between me and the Club regarding the subject matter hereof, and may be modified only in a writing signed by the party to be charged. The above release and indemnity provisions are intended to be as broad and inclusive as permitted by law. The provisions of this Agreement shall be interpreted in such a way so as to render them valid whenever possible, and any ambiguity shall not be strictly construed against the Club. If any part of this Agreement is held invalid by a court having jurisdiction, the remainder shall continue in full force and effect.

JUNIOR PLAYING MEMBERSHIP RESPONSIBILITIES

Please keep for your information

1. A Junior Playing Member is under the age of 22.
2. A Junior Playing Member of the Club shall be of tournament level caliber or actively involved in Badminton activities, such as the Southern California Badminton Association (SCBA) or USA Badminton (USAB).
3. A Junior Playing Member shall be a player whom the Junior Badminton Chairperson has selected for membership and who have demonstrated to be a player with potential to play at/or has tournament level ability and experience.
4. All Junior Playing Members shall be approved by majority vote of the Board of Directors. Appointment to Junior Playing Member status shall be for a period of six (6) months. Prior to the termination of each six month period, the qualifications and playing status of each Junior Playing Member shall, upon the presentation of the Junior Badminton Chairperson, be reviewed by the Board of Directors and, when found satisfactory, reappointment shall be for another period of six (6) months.
5. A Junior Playing Member agrees they will participate in the Junior Training Program. A Junior Playing Member may only use the Club facilities during the training session times listed or under the direct supervision of the Coach.
6. A Junior Playing Member may not bring guests nor shall their parents be allowed to act as chaperones or supervise the Junior Playing Member at the Club.
7. Junior playing Member monthly dues are \$35.00. This may change without notice.
8. A Junior Playing Member is subject to all rules of the Club and obligations of membership as described in the By-Laws and Rules:
9. A Junior Playing Member may not use the pool, spa or other Club facilities unless they are a guest of a Regular Member (or above) and must be signed in as a guest using the waiver of liability located near the spa.
10. Junior Playing Members must participate in the junior Badminton Training to be eligible for Club sponsorship to the Junior National Championships.
