NEW MEMBERSHIP SPONSORING PROCEDURE

1. Existing members must obtain application form from the Vice President and return the completed application form to the Vice President.
 - a. Sponsor must have been a Regular Member for at least one (1) year and must have known prospective member for at least one (1) year.
2. Explain the workings of the Club so that your Prospectives understand that this is a cooperative club and all members must do their share of “workdays” as well as work on an assigned party.
3. The Vice President will present the application to the Board and publish the names of the Prospectives in the *Shuttlecock*.
4. It is your responsibility to see that your Prospectives meet the Board. They cannot be considered for membership until they have been published and have met with the Board.
5. Once the Board has met your Prospectives, the Board will vote on their application at the next regular Board Meeting.
6. The Prospective members will receive an invitation in writing to join the club when there is an opening in the membership.

MBBC MEMBERSHIP APPLICANTS- Please read and sign below

We wish to submit our application for membership in the Manhattan Beach Badminton Club and agree to the following:

Each Member must:

1. Attend two (2) General Membership Meetings per year (2nd Sunday in November and 3rd Sunday in May). One meeting may be proxied.
2. Earn three (3) workdays per year (June 1 to May 31). Workdays include working on parties, tournaments, fundraisers, maintenance days and special projects.
3. Work on the New Year’s Eve Party Committee the second (2nd) Year of Membership and then every four (4) to five (5) years after.
Non-Participants are fined \$25.00 plus the ticket price of the party.

NOTE: A fine is assessed for each service obligation not satisfied during the year (June to May) as:

- One (1) missed workday or meeting fined at **\$50.00** (\$50 total)
- Two (2) missed workdays and/or meetings fined at **\$100.00** each (\$200 total)
- Three (3) missed workdays and/or meetings fined at **\$150.00** each (\$450 total)
- Missed meetings are charged at the rate resulting from missed workdays

Any member who fails to meet any of the workday obligations during any two (2) year period may be asked to resign from the Club.

4. In addition to the above mandatory service obligations, Members are encouraged, when asked, to serve on the MBBC Board of Directors.
